Since the debtor loses control of its assets immediately upon filing a Chapter 7, most debtors with any prospect of rehabilitation (and some that do not) elect Chapter 11. If a debtor files under Chapter 11, in most circumstances it can later convert its case to Chapter 7 and liquidate its assets.
