Certain aliens who are in the United States may file Form I-765, Application for Employment Authorization, to request employment authorization and an Employment Authorization Document (EAD). Form I765 requires an EAD category code to judge your eligibility. You should write the correct EAD category code to avoid any RFE (request for evidence).
